4. Organizational Changes as of April 1, 2015

- 1) Furukawa Electronic aims to accelerate activities at the cross-sectional solution business in the information communication area with the mutually linked, seamless planning and promotion of business strategies. To this end, Furukawa Electronic will establish the Information Communication Solution Division, under the direct control of the president, which comprises the Fiber and Cable Products Division, the FITEL Products Division, and the Broadband Products Division as its internal organizations.
- 2) In addition, the newly established internal organizations of the Information Communication Solution Division include the Solution & System Department, designed to promote the solution business primarily in technologies and products of this division, as well as the Planning Department, comprising the Global Business Strategy Office and the Planning Management Unit as its internal organizations.
- 3) The Electronic Appliance Wire & Products Division is to be abolished and replaced by the Electronic Appliance Wire Department, newly established as an internal organization of the Fiber and Cable Products Division. The function of The Electronic Appliance Wire & Products Division is transferred to the Electronic Appliance Wire Department.
- 4) To strengthen activities to expand trade areas overseas, under the direct control of the president, the Global Business Development & Group Strategic Initiatives Initiae will be renamed the Global Business Development Division. The Global Business Planning and Development Department and the Overseas Sales Department are

- established as its internal organizations, to succeed a part of the overseas sales functions as well as the function of controlling overseas distributors from the Sales and Marketing Division.
- 5) We will abolish the Project Development Unit, an internal organization of the Sales and Planning Department in the Sales and Marketing Division, and simultaneously transfer the function to an internal organization, the Society and Infrastructure Department, of the Sales Management Department for Ecology and Infrastructure in the same division.
- 6) To strengthen ties among multiple divisions related to the automobile business, we will establish the OneF Automotive Business Development Team as an internal organization of the Strategy Division.
- 7) Change in the Scope of Responsibilities of Advisors of Business Divisions We will abolish the positions of advisors of the Ecology & Infrastructure Business and the Electronics & Automotive Business and conduct a review as follows:
 - i) To establish a vertical link with a focus on a supply chain within the group, we will establish the Electronics & Automotive Systems Department. The Advisor is in charge of the Copper & High Performance Material Division, the Electric Conductor Division, and the Magnet Wire Division.
 - ii) The post of advisor of the Functional Components Division will be added and such person shall be in charge of the Copper Tube Division, the Thermal Management Solution & Products Division, the Memory Disk Division, and the Functional Plastics Division.
 - iii) Incidentally, the Information Communication Solution Division, the Automotive Products Division, the Power Cable Division, the Industrial Cable & Power Cable Accessories Division, and the Copper Foil Division will be under the control of the president and the divisions have no position of advisor
