Notice of Change of President and Representative Director

Furukawa Electric Co., Ltd. announces that a meeting of the board of directors held today resolved to change president and representative directors. Details are as follows;

1. Reason of the change

While the business environment is changing more severely and dramatically, the company intends to rejuvenate the President and Representative Director, the top management, in order to further strengthen the market orientation, to accelerate the mid-term management plan, "Furukawa G Plan 2020" and to enhance the growth, development and corporate value.

As part of strengthening corporate governance, the company has established a nomination and remuneration committee, where outside directors make up a majority of the members, and deliberates personnel changes and remuneration etc. of directors, executive officers and senior fellows. This decision was also resolved at the Board of Directors held today following the decision of the change plan at the committee held on December 21, 2016 based on the President's Succession Plan discussed by the committee since last year.
