- (1) Establishment of the "Transformation Division"

  Division to the Global Marketing and Sales Division.
- (6) Establishment of the Functional Components Division
  - The "Functional Components Division" will be established to oversee the "AT & Functional Plastics Division", "Thermal Management Solution & Products Division", "Memory Disk Business Division" and "Copper Foil Business Division".
